Installation:

Waterproofing Sheet Membrane shall be installed in accordance with the manufacturer's published instructions and the applicable code(s).

Ceramic tile must comply with ANSI A137.1

When provided with a clamping ring with open weep holes, the drains shall be installed in accordance with ASME A112.6.3 or ASME A112.18.2/CSA B125.2 as applicable.

Jaeger Waterproof Sheet Membrane Gen1: Composite sheet membrane comprised of an inner layer of polyethylene between two outer layers of polypropylene nonwovens.

Jaeger Waterproof Sheet Membrane Gen1 Corners: Pre-formed interior and exterior angles constructed from the Jaeger Waterproof Sheet Membrane Gen1.

Jaeger Waterproof Wall and Floor Gaskets: Flashings for pipe and drain penetrations formed from an interior layer of thermoplastic elastomer and two exterior polypropylene nonwovens.
